A HISTORY OF PHOCAS CHAPTER

ORIGINS

Phocas Lodge № 9295 was Consecrated on 30th November 1988. It had its origins with experienced and enthusiastic Masons living in the Cheshunt area. The name of the Lodge was taken from St Phocas, a Christian martyr who lived on the Black Sea coast at Sinope in what is now Turkey. This was felt to be appropriate as the founders wanted to honour the memory of a Brother Bobby Price who had been a market gardener in Cheshunt and had been a mentor to many of the Founders.



As the Holy Royal Arch is the "completion of pure, antient Freemasonry" it was proper that the Brethren of Phocas Lodge should seek to enhance their Masonry by bringing into being a Royal Arch Chapter. This was the origin of Phocas Chapter Nº 9295.

In the years since, Phocas Lodge has been the main, though not exclusive, source of members for Phocas Chapter, and has supported the Chapter generously.

E Comp Darren Bending gave a talk on "Variations on the Exaltation Ceremony".

E Comp Tim Coles introduced himself as our Chapter Liaison Grand Officer, and gave an account of the various initiatives being taken by Provincial Chapter.

A Cheque for £1,000.00 was presented to E Comp Tim Coles for the Craft 2019 Festival.

E Comp Michael Phelan gave an account of the information he had received about the possibility of moving the Chapter to Denmark, at the conclusion of which he asked if any member wished to propose that the Chapter take that decision. No Companion did so, and the matter was closed.

SEVENTY-THIRD REGULAR CONVOCATION, 1st February 2018

The following were Installed as Principals – MEZ E Comp L Courtney; H E Comp R Bewell was unable to attend, so E Comp J llott occupied the Chair of 2nd Principle for the duration of the meeting; J E Comp P Goodall was unable to attend and the Chair of 3rd Principal was occupied by E Comp D Williams for the duration of the meeting.

E Comp Michael Phelan gave Notice of Motion that, at the next meeting of the Chapter, he would propose that the affairs of the Chapter would be wound up and the Charter returned, due to lack of members meaning that the Chapter was no longer viable. September would be the last meeting of the Chapter'

E Comp Michael Phelan rose and gave Notice of Motion that, at the next meeting of the Chapter, he would propose that, subject to the proposal to return Charter being passed, the property and assets of the Chapter would be disposed of as agreed by the Companions.

Provincial Grand Lodge of Hertfordshire has recognised the Chapter's support for the 2019 Festival by issuing us with a "Certificate of Support".

Minutes of a GP Committee meeting held on 7th December 2017 had been circulated at which those Companions present had reluctantly recognised that the Chapter was no longer viable. Rule 71 of the Royal Arch Regulations was enacted with regards to E Comp N Jenkins.

SEVENTY-FOURTH REGULAR CONVOCATION, 5th July 2018

The Companions stood for a minute of respectful silence in memory of E Comp Martin Wigglesworth, who had served the Chapter as Janitor for many years.

Pursuant to a Notice of Motion given at the February 2018 meeting E Comp M E Phelan rose to propose that, due to a dwindling membership and no immediate prospect of Candidates, the Phocas Chapter 9295 has ceased to be viable and, accordingly, the meeting to be held at Halsey Hall, Cheshunt, on Thursday, 6th September 2018, will be considered as the last meeting of this Chapter, and thereafter the affairs of the Chapter will be finally wound up and the Charter of the Chapter and any such documents and records as are required, be returned to the First Grand Principal, in accordance with Rule 190, Book of Constitutions.

This was seconded by E Comp Paul Blakemore, and carried without dissent.

Pursuant to a Notice of Motion given at the February 2018 meeting E Comp M E Phelan rose to propose that, subject to the proposal to surrender the Charter being carried, the assets of the Chapter be disposed of as agreed by the Companions. This was seconded by E Comp Paul Blakemore, and carried without dissent.

E Comp Vic Britton, Treasurer, proposed that the funds held by the Chapter for Benevolent purposes be donated to the 2019 Festival and the balance of funds held to be passed to Phocas Lodge 9295. This was seconded by E Comp Paul Blakemore, and carried without dissent.

E Comp Tim Coles gave a very enlightening talk on the many initiatives launched by the Provincial Royal Arch Chapter in recent years. E Comp Michael Phelan thanked E Comp Tim Coles for giving such an interesting talk, and urged all Phocas Chapter Companions to use this information in playing an active role in whichever Chapter they transferred their membership to.

SEVENTY-FIFTH REGULAR CONVOCATION, 6th September 2018

The final meeting of Phocas Chapter took place at Halsey Masonic Hall, Cheshunt, on the above date. The Deputy Grand Superintendent, E Comp David Hampton, represented the Provincial

Chapter, and was accompanied by the 2nd Provincial Grand Principal, E Comp Paul Blakemore (also a member of the Chapter), the 3rd Provincial Grand Principal, E Comp Phil Masters, the Provincial Grand Scribe E, E Comp John Linley, accompanied by E Comp Robert Paul Wale, Provincial Deputy Grand Director of Ceremonies, assisted by E Comp Mark Aitkins, Past Provincial Deputy Grand Director of Ceremonies. In addition, there were 9 Provincial Grand Officers and 18 Guests and Visitors. E Comp Darren Bending stood in as Director of Ceremonies of the Chapter. The Chapter stood in silence as a mark of respect for E Comp Ian Clift, **PGSwdB**, and Past Deputy Grand Superintendent, who had died on 23rd August 2018. E Comp Tim Coles delivered the eulogy. The Deputy Grand Superintendent took the Chair, invited his officers to take their places, and addressed the Companions. A very moving Service of Thanksgiving was held, followed by the Return of the Symbols of Harmony and the Surrender of the Chapter Charter. The Principals, and acting Principals, of the Chapter resumed their Chairs and closed the Chapter for the last time.

During the course of the Chapter's history there have been 33 Exaltations, and 7 Companions became Joining Members. The peak membership came at the meeting on 2nd September 2004, when the summons showed membership at 41.

The Chapter encountered some difficulties. In 2002 E Comp Paul White took the MEZ Chair for a second time and, in 2007, for a third time. In the 24 years of the Chapter's existence, the MEZ Chair was occupied by a member who had previously occupied that Chair in 10 of those years, which suggests that there may have been a reluctance among Companions to graduate through the ranks.

There may have been a problem with recruitment and retention. The last Exaltation was in July 2011, and before that 2009. Of Exaltees during the Chapter's existence, 13 appeared on summonses for, on average, fewer than 14 times. This may emphasise the need for Mentoring and the advisability of putting into action the various initiatives which Provincial Grand Chapter has recently launched.
